



WORKS NOTIFICATION

NIGHT WORKS AND ONGOING SERVICE INVESTIGATIONS, DOMAIN 8 MARCH - LATE APRIL 2017

Works in preparation for major construction of the Metro Tunnel are continuing in the Domain precinct with the relocation of utility services near the Shrine of Remembrance and further service investigations.

From Wednesday 8 March 2017, a combination of night and day works will be required to continue power relocation works and to conduct a CCTV sewer inspection. Much of this work needs to be completed at night to ensure the tram network and road traffic are not affected.

What we are doing

Power relocation night works

- Relocating the power service beneath Domain Road near the corner of St Kilda Road
- Using open cut trenching to excavate down to the required depth, installing the new service, backfilling and reinstating the area
- Temporarily closing lanes on Domain Road as the work progresses.

South Yarra main sewer investigation night works

- Inserting a camera into the underground sewer for inspection at Domain Road, South Yarra and removing it from the sewer at Albert Road, South Melbourne.

Non-destructive digging (NDD) day works

- Digging holes or narrow trenches to carefully expose underground utilities and verify the location of each service in Park street, Bromby Street, Domain Street, Toorak Road West and Albert Road (South Melbourne).

CCTV sewer investigation day works

- Confirming and identifying the location of underground services on Park Street, Bowen Crescent, Bromby Street, Domain Street, St Kilda Road and Albert Road by placing CCTV into sewer and drainage services.

What to be aware of

- These works (known as enabling works) do not require assessment under the Environmental Effects statement, and have been granted the relevant planning approvals to proceed
- The location of NDD sites may vary depending on the results of the investigation works
- Traffic management will be in place to ensure the safety of work crews, pedestrians, cyclists and maintain flow of traffic around the work areas
- Access to private properties and businesses will be maintained at all times
- There is no planned disruption to essential services
- Impacts from noise, dust and vibration will be managed in accordance with the Metro Tunnel's Environmental Performance Requirements (EPRs)
- There will be staged lane closures and occupation of car parking spaces during works
- Work areas will be reinstated at the conclusion of works
- These works (known as enabling works) have been granted the relevant planning approvals to proceed.

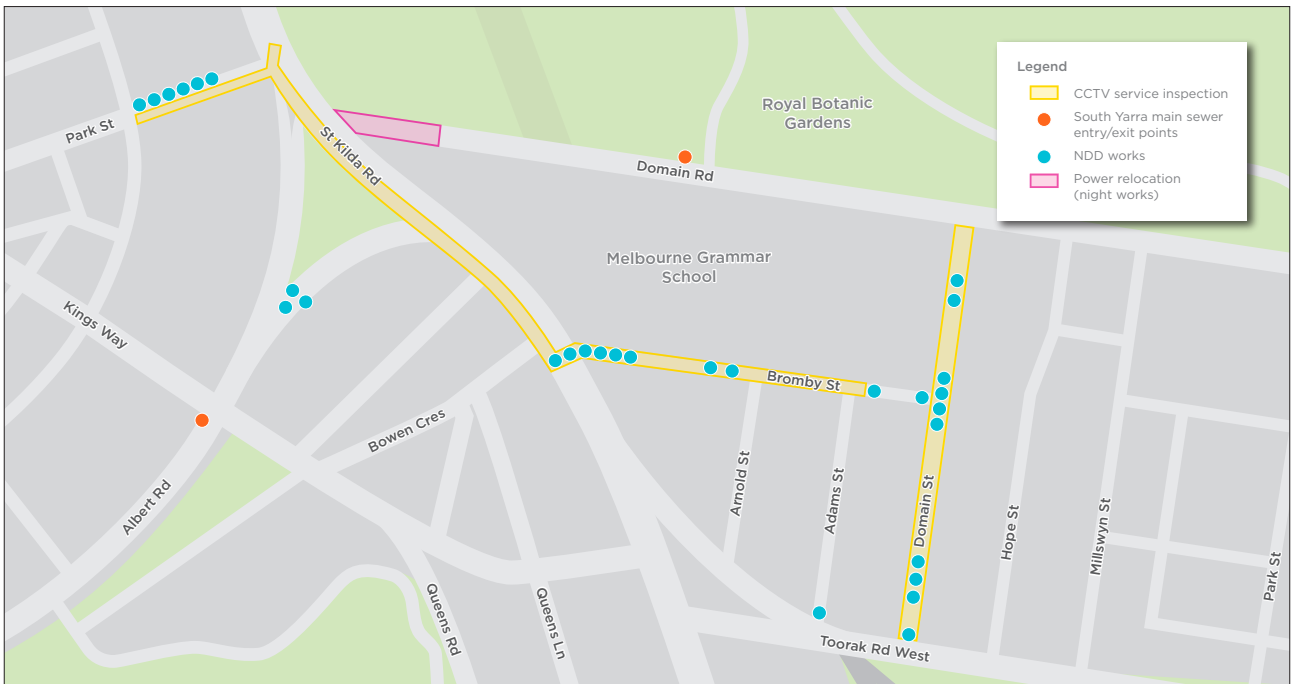

The Power relocation night works will take place on Wednesday 8 March and Thursday 9 March, and between Tuesday 14 March – Thursday 16 March 2017.

The CCTV sewer night works will take one night during the notification period with very low level impact.

We will notify residents and businesses if there are any significant changes to the program.
